## **Grand Treasurer's Report**

Grand Treasurer, Brother Jack Albrecht, presented his Treasurer's Report dated August 21, 2012 via the Business Manager, Br. Tom Fourie. This report showed the balances for the YMI fiscal year as they stand for the 2012-2013 year. There were no questions.

MSC – Terry/Dimech – Unanimous - to accept the August 21, 2012 Grand Treasurer's Report.

#### **Board of Grand Directors' Committee Reports**

Chairman of the Board, Brother Michael Dimech asked for reports.

- Charters ~ Br. George Terry, Chr. ~ Review the need for anniversary charters and the replacement of lost charters as needed. No report at this time
- Finance ~ Br. Michael Dimech, Chr., Br. Richard Pisciotta, and Br. George Terry ~ Review and approve for payment all bills for Grand Council. All bills for August have been reviewed and approved for payment.
- Long Range Planning ~ Br. Charles McClure, Chr. and Br. Peter Pasini ~ Update and edit the Five-Year Plan for the Young Men's Institute. There needs to be a meeting during the Official Visit to Indiana with Br. McClure present to begin the work of this committee.
- Council Activities ~ Br. Bill McNeany, Chr., Br. Richard Pisciotta ~ Review and sign off on forms submitted by Councils for activities which could gross more than \$1500. No forms submitted
- Supplies ~ Br. Michael Dimech, Chr. ~ perform an annual inventory of YMI property at the World Headquarters. Br. Fourie reported that 25 year pins will need to be ordered.

- Insurance ~ Br. Nick Franceschine, Chr. ~ Work with the Grand Council Office on any possible liability claims against the Order through the Travelers Insurance Company. No report from Br. Nick, however, Br. Fourie had received the first billing for the new YMI year and the premium had been reduced. Br. Fourie restated that the insurance covers event held at the meetings and socials at the designated site appearing on the certificates. It is a liability insurance.
- Fund Raising ~ All Grand Directors ~ spear head all fund raising efforts to offset Grand Council expenses during the year Br Pisciotta brought forward both information and discussion of having a Night at the Races and that his documents would be sent to each Grand Director. Br. Dimech to hold a special Grand Director conference call to further discuss this matter. The idea of a Casino Night was also brought up.
- "Proud To Be Catholic" ~ All Directors ~ possibly held in conjunction with the Red and White Mass. Brother Luther confirmed the March 2, 2013 date at Immaculate Conception Church in Atwater – 5:00 p.m. Mass – dinner \$20 at the St. Anthony's Hall in Atwater. A flyer was approved and there were questions about beverages being served. Fr. Agnel had been contacted regarding a letter to say Mass.

## **Grand President's Report**

Grand President Frank Hepburn was absent for this meeting, attending the Red Shirt Breakfast for American Council #8. He had e-mailed his report to everyone on September 2, 2012. Br. Fourie summarized this written report. Events covered: Columbus Day Parade, Red Shirt Breakfast, Official visits in July, Bocce Ball Tournament (bringing 6 people with him).

#### **Grand Secretary's Report/Business Manager's Report**

Grand Secretary Michael Amato reported on his letter to the new Archbishop and accompanying advertisement.

Business Manager Tom Fourie reported on the following:

• Councils #612, #94 and #92 have not sent in the July assessments.

- The Institute Journal and its publication process was discussed to include, picking up the printed Journals, cost of printing, cost of mailing, cost of labels, and all the usual trappings. Board Chairman Michael Dimech appointed Brothers Fourie and Amato to research alternatives to publish and circulate future Jounnals.
- Brother Fourie presented a check from the Noel Smith Trust for \$75,095.04. After two years of legal proceedings the Borel Private Bank and Trust was directed to dissolve the trust. The money is to be used for the youth of San Mateo County. The check needs to be deposited in a special YMI account under the Operating Budget of Grand Council (give to the Grand Treasurer to do this). A discussion ensued about dispensing the monies to Catholic High Schools on the Peninsula, all who participate in our Essay Contest and receive scholarship help from existing YMI Councils. Suggestion was made to give each (there are three) \$25,000 to be used for scholarships to their schools. At the next meeting of the Board of Grand Directors, a decision needs to be made.

A discussion on the issuing of W-9s for checks written to officers, raffle winners, etc. in the amount of \$600 or more. Br. Fourie summarized that all Grand Council Officers who receive more than \$600 during the YMI year are to get a W-9. The other two events would be students from the Essay Contest (only two winners) and the winner of the Pro Patria Raffle drawing of \$1000. The Grand Secretary will draft a motion to be presented at the next Grand Directors Meeting to officially make the issue of W-9s final.

A new set of forms and paperwork has been sent to the Group Exemption Unit of the State Franchise Tax Board so that the 30 councils operating in California will be covered as a group
