<u>YOUNG MEN'S INSTITUTE</u> BOARD OF GRAND DIRECTORS BI-MONTHLY MEETING <u>MINUTES</u>

Call to Order

Chairman of the Board, Brother Michael Dimech, called the meeting to order at 9:02 a.m. on Saturday, September 21, 2013 in the World Headquarters of the YMI in South San Francisco, California.

Unfinished Business

Br. Bartoli reviewed the 129th Grand Council Session planning thus far for South Lake Tahoe in 2014. \$129 per night for rooms. The Session will begin with a Mass on Monday and close on Wednesday with a Mass and Grand Banquet.

For the 130th Grand Council Session, Brother Evans is leaning toward the Silver Legacy in Reno, but will give us his final decision.

For the 131st Grand Council Session, Br. George Terry indicated that there was interest in a cruise of some sort.

The Bocce Ball Tournament is next Saturday according to Br. Michael Dimech. There are 16 teams as of now. Remember to bring canned goods for the poor and #32 will bring the coffee and donuts.

A Membership Report was tabled by Grand President Reza.

A serious and lengthy discussion ensued on Grand Council fund raising.

- Dimech difficult to have a fund-raising event
- Amato can we focus on raffle ticket sales improvement
- Albrecht members are too old
- Fourie Councils could contribute \$100 to a 50/50 raffle
- Any type of raffle program will be decided on November 2, 2013 at the next meeting

Another serious discussion on the present condition of the YMI website. We need a new website coordinator, will bring it back to the board and will be looking for names to be sent to Brother Amato.

A response to Council #497's letter for financial help took place. Everyone had an opinion or a series of questions: stop payment on per capita, direct check from reserves, lack of Council participation in Grand Council events, poor raffle ticket sales, review their tax forms and finances, what are their dues?, etc. The request was tabled until November 2, 2013.

Question on Petaluma Council #9 situation – Br. Franceschine stated they plan to merge with Sebastopol Council #54 and #54 agreed. Brother Fourie asked for a meeting with representation from the Grand Council, #9 and #54. Br Franceschine would coordinate this meeting.

New Business

Brother Michael Dimech distributed his rough draft concerning the possibility of the Board of Grand Directors Award to be announced at each Grand Council Session. He asked that everyone review what he wrote and that it be taken up under Unfinished Business at the next Board meeting. He would appreciate any comments by October 25, 2013.

A check for \$500 had been donated to Grand Council from a YMI member of San Francisco Council #1. This check was sent in memory of his late father who was also a YMI member. The Board discussed on how it might best be used.

MSC – Bartoli/Franceschine – unanimous – that the funds be used towards the new YMI website.

Br. Michael Dimech brought up the situation with Grand Director Charles McClure from Gonzaga Council #612 in Richmond, Indiana. As a board member, Br. Dimech had informed him that his lack of participation was hindering the responsibilities of the Board. He asked him to call in or it would be assumed that he no longer wishes to be a board member and the board would assume he resigned. See Article II, Section 9 of the Grand Council By-Laws. Br. Dimech asked him to write a letter to document his decision.

Grand First Vice President's Report

Brother Luther's report was read by Br. Fourie. His report centered on visits to other Councils and the up coming Pro Patria Raffle and Essay Contest.

Grand Second Vice President's Report

Again, Br. Terry already referenced the Red and White Mass. He reported that he planned to increase his visits to other Councils.

Junior Past Grand President Report

Brother Frank's report was given under Membership and his efforts to work with District Deputies.

Good of the Order

Brother Franceschine thanked all the Brothers for attending the BBQ in Sebastopol.

Closing Prayer

The closing prayer led by Br. Frank Hepburn in memory of Brother Bill Effinger II, the father of Grand Council Officer Bill Effinger III.
