<u>YOUNG MEN'S INSTITUTE</u> BOARD OF GRAND DIRECTORS BI-MONTHLY MEETING <u>MINUTES</u>

Call to Order

Chairman of the Board, Brother Alan Patrick, called the meeting to order at 7:02 p.m. on Friday, June 26, 2015 at the World Headquarters of the YMI in South San Francisco, California.

Opening Prayer

The opening prayer, "The Brotherhood Prayer", was led by Grand Director Alan Patrick in honor of the new Grand President, Brother George Terry, requesting God's guidance on the officers and their deliberations throughout the meeting.

Pledge of Allegiance

In a true spirit of fraternalism, the Pledge of Allegiance, led by Grand Outside Sentinel Larry Andreatta, was recited in a strong voice by those assembled. All were asked to remember our country's service men.

Roll Call

Reading of the Minutes

Communications

The Business Manager and the Grand Secretary presented the following communications:

Grand Treasurer's Report

Grand Treasurer, Brother Jack Albrecht, reviewed his two reports dated June 22, 2015. These reports were the expense spreadsheet and the income spreadsheet. He also reported that the reserve funds were at \$211,722.

Brother Bob Bartoli asked a question about the Awards category.

Board of Grand Directors' Committees

Chairman of the Board, Brother Alan Patrick, wants to keep Brothers on the same committees they were on the previous year. He asked if there were any comments to this plan. He asked that all Brothers review their responsibilities. He appointed Brother Manuel Drumonde to the Long Range Planning Committee. He also hoped that the Chair Officers would join this committee. Individual committee reports are expected at the next Board of Grand Directors Meeting in September.

Grand President's Report

Grand President Brother George Terry announced he would be making an appearance at the YLI Convention in Modesto tomorrow. He will be accompanied by Brother Tom Fourie, #32, PGP.

Grand Secretary's Report/Business Manager's Report

Grand Secretary Michael Amato spoke to the Internet and what was happening as of this day. Brother Albrecht asked questions concerning Memorials, updating Council information and seeking input from Councils about changes.

Business Manager Tom Fourie reviewed the work of the World Headquarters since the last Board of Grand Directors meeting:

- The semi-annual report from Stockton Council #5 has yet to be received.
- On this past Tuesday, he drove to the Flamingo Hotel in Santa Rosa, CA to discuss the 2016 Grand Council Session. He informed the hotel that we would have one less day for the Session and they were still willing to hold the price to \$129 per night (the same as years past). Br. Fourie reported on the poor quality of food served at the Grand Banquet a few years back. The representatives said that has all changed and we will have a new menu from which to choose. The Hotel will send a confirmation letter and contract and will need a \$1000 deposit.

A complimentary room for the Grand President and Grand Chaplain will be provided. \$300 will need to be spent at the bar prior to the Grand Banquet. Brother Dimech asked if a minimum number of rooms have to be reserved, the answer is yes ---- 61 rooms.

- Brother Fourie reported on Council #94's questionable membership roster. He spoke with Br. Red, Council Secretary, about the 12 missing membership applications.
- The next Assessments will be redone in line with the membership reports presented at the Grand Council Session (which were derived from the Semi Annual Reports).
- The Liability Insurance policy turnover date is June 18, 2015. The agent has once again changed, however, we are bound over and now more forms need to be completed and certificates need to be issued. Fourie to take care of this.
- Looking for articles for the next Institute Journal (7-31-2015)
- Brother Fourie represented the YMI at Mercy Burnlingame with the Pro Patria Essay prizes
- Much follow up to the 130th Grand Council Session

Grand Directors Report on Grand Council Committees

Grand Session Planning Committee (Br. Tom Fourie, Chr.) – all the information was presented in the report previously given by the Business Manager.

Grand Session/Credentials Working Committee (Br. Michael Amato, Chr):

Institute Journal (Br. Tom Fourie, Chr.) – Br. Fourie announced the next deadline is July 31, 2015.

Laws and Revisions (Br. Rob Bartoli, Chr) – Br. Bob Bartoli read the report of the committee on Council #32 changes for delegate compensation:

A brief discussion on the Death Benefit Survey ensured. Some discussion about clarity of instructions at the Grand Council Session was entertained. The survey is on the website.

There was no fund raising report at this time.

Chairman of the Board, Br. Alan Patrick, asked what the Board wanted to accomplish this year:

- a. getting the archives taken care of.
- b. working the long range planning with the chair officers.
- c. to give something back to the Councils \$?
- d. need to look at the website to send out the Journals as well as an e-mail attachment.
- e. Death Benefit to become a State of the Institute issue.

Plans for the 131st Grand Council Session: Br. Dimech asked when to make a decision. Other items were the cruise, the Peppermill in Reno, etc. Need a decision by the end of 2015.

Grand First Vice President's Report

Brother Dimech wants to visit more Councils working with Br. Terry. He wants to talk to each Council about having a raffle chairman. He is presently working on the Bocce Tournament. He is aiming for October 2, 2016 to mail out the Pro Patria Tickers.

Grand Second Vice President's Report

Br. Luther Evans spoke on behalf of Br. Mike Nelson. The date of March 5, 2016 has been set for the Red and White Mass in Atwater, CA. Mass at Immaculate Conception Church and dinner at St. Anthony's Hall.

Junior Past Grand President Report

Br. Evans thanked all Board members and Grand Council Officers. He wondered aloud why there isn't a two year term for the Grand President???? Br. Luther was asked to write a summary article of the 130th Grand Council Session for the Journal. He agreed.

Good of the Order
