# YOUNG MEN'S INSTITUTE BOARD OF GRAND DIRECTORS BI-MONTHLY MEETING <u>MINUTES</u>

# Call to Order

Chairman of the Board, Brother Bob Bartoli, called the meeting to order at 8:30 a.m. on Saturday, January 21, 2017 at the World Headquarters of the YMI in South San Francisco, California.

### **Opening Prayer**

The opening prayer, led by Grand Outside Sentinel Steve Cresci, requested God's guidance on the officers and their deliberations throughout the meeting.

### Pledge of Allegiance

### **Grand Treasurer's Report**

Grand Treasurer, Brother Jack Albrecht, reviewed his two reports dated from December 2016. These reports were the expense spreadsheet and the income spreadsheet.

He invited all to ask questions. The \$1260 was a pass through from the recent Grand Council Session.

**MSC -** De Vita/Carinalli – Unanimous - to accept the Grand Treasurer's report of December, 2016.

# **Board of Grand Directors' Committees**

Chairman of the Board, Brother Bob Bartoli, requested reports from the various Grand Director's Committees:

Charters/Archives – Brother Bill Walls, Chr. – no report at this time, however, Br. Albrecht provided some material

Finance: Brother Bartoli, Chr. - reported all bills were in order and they have been paid.

Long Range Planning – Br. Matt Nelson, Chr. – The Chairman stated that he was trying to update the Report for our next meeting. Brother Fourie reminded him that the report is needed before that date and could he move up his work by one month. The Chairman replied in the affirmative.

Council Activities – Br. Carinalli, Chr. – no report at this time from the Chairman, however, Br. Fourie was in receipt of two requests from Council #54: a pasta dinner and a corned beef dinner, and both had been approved.

Insurance – Br. Franceschine reported that there was no activity since the last Board Meeting and there have been no claims.

Members of #32 and #613 provided all the man and women power to work the event. It was a good model for a fundraiser for any Council according to the Grand President. He wants to continue doing this again maybe next November. A round of applause followed this report.

Supplies – Brother Mario De Vita, Chr. – no report until February 21 when the inventory is taken.

### **Grand President's Report**

Grand President Brother Michael Dimech spoke on several topics:

- Br. Dimech summarized his visit to Indiana along with Brothers Mike Amato, Tom Fourie and Richard Guaraldi. He was met by Br. John Mundy in Huntingburg, had a nice Saturday night dinner at their restaurant/bar. Attended Mass/Breakfast the next morning with YMI families (65 in attendance). They are doing much better now as a club. The next day was attendance at Mass at St. Meinrad's Archabbey walked the grounds..nice and calm. From Monday to Thursday, the visit centered on Richmond, IN. Greeted by Br. Scott Vogelgesang, Mass with the students at Seton Catholic High School, visited the high school as well as the elementary schools. The principal spent half of a day with us...very nice. # Grand First Vice President's Report

Brother Nelson was on the conference line from Mariposa, CA.

The Pro Patria Raffle goal is \$12,000. At this time we are at \$7500.00. He read aloud the sales percentages by Councils. Brother Fourie reported that the YLI is doing very well in supporting the raffle. It would be good to get 20% of the YMI membership to participate.

Br. Nelson asked the Grand President to urge the District Deputies to promote the raffle in each of their Councils and they each should have a raffle chairman.

Fourie reported on the essay contest, another year of 1500 submissions.

Br. Nelson reported he went to Hilmar's installation and attended the Pasta Bingo in South San Francisco.

# Grand Second Vice President's Report

Br. Rivas reported that the Annual Red and White Mass has been set and will be held on March 11, 2017 at St. Rose Catholic Church in Santa Rosa. Council #40 will prepare a dinner after the 5:30 p.m. Mass. He has sent out all the fliers and hopes to receive many reservations in advance. There will be a no host bar before dinner (after the Mass). He suggested a raffle at the event, but was informed that the Pro Patria Raffle will take place after dinner and it would not be wise to have two. He confirmed he would have a drum for the raffle. The Red and White Mass flyer is on the website.

**MSC** – Bartoli/Walls – Unanimous – for Grand Council to contribute \$500 out of fundraising to help defray the cost of a bus from the San Francisco District to Santa Rosa for the Red and White Mass.

He also attended the Pasta Bingo in South San Francisco.

- Prepared and mailed Assessment #165
- Several hours spent on the paperwork for the Education Foundation
- Re-edited the Journal
- Attended #32's business meetings

Notified the Board of the work with the Journal in transportation, etc. Brother Hepburn volunteered to pick up the next issue of the Journal and bring it to SSF.

World Headquarters will be doing most of its work from 7:00 p.m. to 7:00 a.m. on weekdays as well as on the weekends from now on.

**Budget** (Br. Jack Albrecht, Chr.): The Grand Treasurer announced the first Budget Committee meeting will take place on February 21, 2017.

**Coordinating** (Br. Michael Dimech, Chr.): Doing what he can at this time to have the YLI buy raffle tickets.

**Ceremonials** (Br. Manuel Drumonde, #44, PGP): Have not started, but the committee wants to work on the funeral rite.

**Grand Session Planning Committee** (Br. Tom Fourie, Chr.) – the deposit check has been sent to the Montbleu Hotel.

Grand Session/Credentials Working Committee (Br. Michael Amato, Chr): will be ready in June 2017.

**Institute Journal** (Br. Tom Fourie, Chr.) – already discussed in the Business Manager's report.

**Laws and Revisions** (Br. Rob Bartoli, Chr) – no report at this time.

**Man of the Year and Council of the Year** (Br. Bob Bartoli, Chr.) – the committee has prepared and published articles/application forms for the website and the Journal.

**Membership** (Br. Matt Nelson and Br. Larry Andreatta, Chr.): Br. Dimech said he will be encouraging the two chairmen to reach out and mentioned the concept of a membership drive. Br. Cresci announced a membership drive at All Souls Church following Sunday Masses in the next week.

**MSC** – Bartoli/DeVita – Unanimous – to cap financial assistance at \$75 from the membership budget to Councils conducting membership drives.

**Organization** (Br. Michael Amato, Chr.): already covered **Pro Deo** (Carlos Rivas, Chr.): See Grand Second Vice President's report.

**Pro Patria** (Mike Nelson, Chr.): completed under the Grand First Vice President's report

**Reserve Fund** (Br. Jack Albrecht, Chr.) – reported the operating reserve balance at \$231,335.15. The Death Benefit Reserve stands at \$1,695,745.87.

**Resolutions** (Br. Nick Franceschine, Chr.): no report at this time.

**State of the Institute** (Br. George Terry, Chr.): Br. Frank spoke on behalf of Br. George. A letter had been sent to each Council requesting any proposals.

**Workshop Committee** (Brother Tom Fourie): will be ready in June 2017.

# **Unfinished Business**

As reported previously, a deposit check has been sent to the Montbleu Hotel for the Grand Council 2017 Session. The Committee will be meeting on January 30, 2017 at 7:00 p.m. at World Headquarters. The 133<sup>rd</sup> Grand Council Session will be in Reno, Nevada. Br. Pisciotta is working on this site. No other work has been done in planning this event as of yet.

Br. Fourie has been in contact with Br. Franceshine in working on the report needed for the Benefit Program. Br. Fanceschine confirmed the type of report. It is in progress.

The Grand Secretary requested that the concept of a new Council in San Leandro be removed as an agenda item.

Council #76 is now terminated.

Br. Fourie read a letter from Br. Smith of Council #9. Payments of assessments for this Council are written on personal checks of Br. Smith. He wants more time to get his Council finances in order. After a discussion:

**MSC** – Bartoli/DeVita – Unanimous – direct the Grand Secretary to write a letter to Council #9 expressing the concern that Grand Council has with the operation or lack of operation within Council #9, and offer help to remedy the situation.

We still need a bowling flyer and we have a bare bones golf flyer.

Thirty YMI hats have been ordered and they will be brought to sell at the Grand Council Session.

### New Business

Discussion on bus to Red and White Mass has been reported above.

A discussion ensued on contributing monies to the Catholic Schools in Hilo (which had sent a request) and to the elementary schools in Richmond, Indiana (to thank the principal for her time)

**MSC** – Carinalli/DeVita – Unanimous – to contribute \$250 each to the Catholic Schools in Hilo, Hawaii and the Catholic elementary schools of Richmond, Indiana.

Brother Jack Albrecht brought to the Board the updating of the Grand Council Death Certificat which had not be changed or reviewed since 2003. The Business Manager will work on a draft and bring it to the next Board meeting.

There was no report at this time.
