JULY MEETING DATE CHANGE

Due to scheduling conflicts, our July regular monthly meeting has been rescheduled to Sunday, July 24, 2022 at 11:00 a.m. at the Immaculate Heart of Mary Church Parish Hall.

2022 GRAND COUNCIL SESSION

After being relegated to online meetings in 2020 and 2021 due to the worldwide pandemic, the Young Men's Institute was pleased to return to an in-person convention at the Bally's Lake Tahoe Casino Resort, formerly the Montbleu Resort, from Monday, June 20 through Wednesday, June 22, 2022. Francis Council was represented by our Worthy President and Grand Director Brother Thomas E. Figueira. Brother Figueira was re-elected to the Board of Grand Directors at the convention and, in addition, Brother Figueira was selected to serve as the Chairman of the Board. We are proud to have Brother Figueira represent our Council in such as auspicious position and we wish him great success.

NEWLY ADOPTED STATE OF THE INSTITUTE BY-LAW CHANGE

At the recent Grand Convention, a by-law change was adopted that allows <u>all</u> dues-paying members to potentially be able to receive Death Benefits. The by-law change eliminates the Associate Member class and converts those brothers to Benefit Members by also removing the 45-year age criteria, creating a single-class of dues-paying brothers that will equally be able to have their beneficiaries receive the YMI Death Benefit (currently set at \$2500). The by-law change further requires former Associate Members and new YMI Members joining after July 2022 to be in the Order <u>for at least 5 years before becoming eligible for the YMI Death Benefit</u>. Those YMI Benefit Members who joined prior to July 2022 are automatically grandfathered into the Death Benefit program and do not need to wait for five years to be eligible.

As a result of the by-law change, the Grand Council will need to collect beneficiary information from all former Associate Members so that it can have a complete record of designated beneficiaries. Accordingly, all impacted brothers will need to complete the brief Beneficiary Designation Form that is included in this Chatter mailing. THE IMPACTED FRANCIS COUNCIL BROTHERS ARE AS FOLLOWS:
