GRAND PRESIDENT'S MESSAGE



Organizational

Committee/Membership: The Young Men's Institute shall remain a "Fraternal Order of Catholic Men"; without exception. Our Constitution is very clear and outlines acceptable Catholic Men as candidates for membership. As most of you know, this issue has been discussed at length over this past year. The Organizational Committee concluded that numerous Councils have established a "Friendship Mailing List" in order to inform YMI supporters of their upcoming Council socials and events. The practice of mailing Council flyers to

non-Catholic supporters has been in practice for a long time, including running newspaper ads in local newspapers soliciting the general public to attend our YMI socials and fund raisers. This practice is in full compliance of our Constitution and By-Laws.

As a Catholic Organization, the integrity of our Constitution and our By-Laws must be preserved and observed in order to maintain a "Strong Catholic Fraternal Organization". Our membership and number of Councils may have dwindled over the past years, however, our principles as a Catholic Fraternal Order, faithful to our Church and teaching of Christ has stood fast since 1883. From time to time, change must take place to preserve our Catholic Order through social and economic change, and how we manage our Order to meet our membership needs. Such changes are made through the YMI By-Laws, Article IV; Section 16, Titled "State of the Institute Committee". The Organization Committee submitted seven possible changes to the YMI By-Laws which will be outlined in the 127th Grand Council Advance Proceedings; which will be voted upon by your Council Delegates at our 127th Grand Session. Please have your Council Members read the Advance Proceedings and discuss to determine how you

want your delegates to vote at the Grand Session.

Thomas E. Pratt, PGP

On January 19, 1954 Thomas E. Pratt joined the Young Men's Institute as a member of Santa Clara Council #84. For his first ten years as a member, he served his Council well as an officer. In 1962, Brother Pratt was elected as a Grand Director for the Grand Council and served his two year term. In 1964 he became the Grand Second Vice President followed by Grand First Vice President a year later. He had to take an absence from Grand Council activities for a few years, but came back in 1969 as the Grand Second Vice President, Grand First Vice President in 1970 and Grand President in 1971 presiding at the Grand Council Session in Oakland, California in 1971. Brother Pratt was very instrumental in assisting with travel plans when the Grand Council held its meetings out of the state of California. In 2000, Brother Pratt transferred his membership to Francis Council #573 in Hilo, Hawaii. He and his wife Esther eventually returned to their home state of Indiana. The family home is located at 1750 W. Porter Avenue, Chesterton, IN 46304. Services were held in Indiana and later in Hawaii. May he rest in peace.

STATE OF THE INSTITUTE 2012

Brothers,

The following seven proposals for changes to the Grand Council By-Laws will be presented on the floor of the 127th Grand Council Convention this June. All Brothers and in particular, all voting delegates, should review these proposals prior to the secret ballot vote.

Proposal #1 Relating to: Grand President Article III, Section 1a

Existing language:

Section 1a: Grand President: At the outset of his term in office, arrange a list of dates for the official visits to the Councils by himself and the Grand Vice Presidents. Each year on a rotating system, the Grand President, Grand First Vice President, and the Grand Second Vice President will each visit one third of the Councils during their term of office.....

Rewrite:

Section 1a: Grand President: At the outset of his term in office, after consulting with the Grand Vice Presidents, arrange a list of dates for official visits by himself and the Grand Vice Presidents. Each year on a rotating system, the Grand President, Grand First Vice President, and the Grand Second Vice President will visit one-third of the Councils and/or Districts in California, with individual visits to Councils in Hawaii, Indiana, and any future Councils formed outside of California during their term of office.....

Rationale:

This Article is biased against our Brothers in Southern California, Hawaii, Indiana – and any future Brothers residing outside the San Francisco Bay Area and California Central Valley. Brothers from these areas are effectively barred from seeking higher office given the logistics and distances involved fulfilling this requirement. Furthermore, this Article is biased against Brothers up to their mid 50's who are still raising families. Again, the distances and logistics involved in meeting this stipulation prevent many from moving through the Chair Offices. The result of this Article leaves retired Brothers in the San Francisco Bay Area and California Central Valley as the only Brothers fully capable of meeting this requirement and diminishes the pool of potential Candidates for the Chair Offices.

Proposal #2 Relating to: Duties of Grand Officers Article III, Section 7

Existing Language:

Section 7: The Board shall provide for a suitable office for the Grand Secretary.

Rewrite:

Since the provision of an office for the Grand Secretary is no longer necessary in today's YMI, we suggest that the one sentence be removed from the By-Laws altogether.

Rationale:

In Article III, Section 7, the Board of Grand Directors are required "to provide a suitable office for the Grand Secretary." Although the YMI provided the Grand Secretary an office in its history, it has not been an operational practice for many years for the YMI to provide such an office. While the requirement can be interpreted improperly by outside government authorities to suggest that the YMI Grand Council owns property and/or that the YMI has provided a benefit to its Grand Secretary. In either case, there could be tax implications.

Proposal #3: Delegates to Grand Council
Article I, Section 1

Existing Language:

Section 1: Delegates Number: Councils shall be entitled to elect Delegates to Grand Council in accordance with their respective net membership as shown by their Semi-Annual Report to Grand Council for the term preceding the Session, excluding Honorary Members from the count. A Council organized following the closing date for Semi-Annual Reports shall have its representation based on its net membership on the date that Grand Council convenes. Councils shall be entitled to Delegates as follows:

75 or less Members	2 Delegates
76 to 150 Members	3 Delegates
151 to 225 Members	4 Delegates
226 to 300 Members	5 Delegates
301 to 375 Members	6 Delegates
376 to 450 Members	7 Delegates

Rewrite:

50 or less Members	2 Delegates
51 to 100 Members	3 Delegates
101 to 150 Members	4 Delegates
151 to 225 Members	5 Delegates
226 to 300 Members	6 Delegates
301 & Over Members	7 Delegates

Rationale:

The number of active Councils and our YMI Membership has declined over the years contributing to fewer members attending our Grand Sessions. Adjusting the number of delegates corresponds with our current number of active Councils and membership, allowing greater Grand Session participation.

Proposal #4, Grand Council Fees and Expenses
Article I, Section 11

Existing Language:

Section 11: Grand Council Fees and Expenses: Each Delegate, Grand Officer, Past Grand President, and District Deputy Grand President, upon registering with the Credentials Committee, shall pay a registration fee of twenty dollars (\$20.00). The fees so collected shall be used to defray the expenses of conducting Grand Council Sessions. In addition, to further help defray the expenses and entertainment of the Grand Council Session, the sum of five hundred dollars (\$500.00) shall be appropriated from the funds of Grand Council and ordered paid by the Board of Grand Directors prior to the convening of Grand Council.

Rewrite:

Section 11: Grand Council Fees and Expenses: Each Council Delegate, Grand Officer, Past Grand President, and District Deputy Grand President, upon registering with the Credentials Committee, shall pay a registration fee of up to fifty dollars (\$50.00) as authorized annually by the Board of Directors. The fees so collected shall be used to defray the expenses of conducting Grand Council Sessions. In addition, to further help defray the expenses and entertainment of the Grand Council Session, the sum of five hundred dollars (\$500.00) shall be appropriated from the funds of Grand Council and ordered paid by the Board of Grand Directors prior to the convening of Grand Council.

Rationale:

The \$20 registration fee has been around for decades. While the fee has been frozen at \$20, expenses incurred to conduct Grand Council Sessions have been continually increasing over the many years. These expenses include providing furniture and electronic equipment (microphones) for the sessions, as well as water, communication and other conference services. Because the fee does not adequately cover increasing Grand Council Session expenses, we have been utilizing declining level of cash reserves to cover the difference. Continued reliance on reserves is not sustainable over the long-term.

Proposal #5, Election of Grand Officers
Article II, Section 1

Existing Language:

Section 1: Eligibility for Office: Only members of Grand Council who have been members of the Order for five (5) years or more and who have served at least one term as an Officer in a Council shall be eligible to any elective office in Grand Council, with the exception that members of Grand Council who have been members of the Order for two (2) years or more shall be eligible for the office of Grand Marshal, Grand Inside Sentinel, or Grand Outside Sentinel.

Rewrite:

Section 1: Eligibility for Office: Only members of the Grand Council who have been members of the Order for three (3) years or more and who have served at least one term as an officer in a Council shall be eligible for (to) any elective office in Grand Council, with the exception that members Grand Council who have been members of the Order for two (2) years or more shall be eligible for the offices of the Grand Marshall, Grand Inside Sentinel and Grand Outside Sentinel.

Rational:

The By-laws in Article II, Section 1 requires certain Grand Offices to be held by members who have been members of the Order for at least 5 years. While this eligibility requirement for office may have been prudent years ago when the organization had robust membership levels, membership has steadily waned over the years. Finding Brothers today to seek Grand Office positions is now more difficult than ever. Moreover, having a 5-year minimal requirement limits the eligibility pool.

Proposal #6, Duties of Grand Officers
Article III, Section 1(c)

Existing Language:

Section 1 (c) Appoint a Grand Organist and a Legal Advisor.

Rewrite:

Given the Article III, Section 1(c) is unnecessary, we suggest removing it altogether from the By-Laws

Rationale:

The By-Laws in Article III, Section 1 (c) state that the Grand President shall "appoint a Grand Organist and a Legal Advisor". This provision in the By-Laws relative to the Grand Organist is out-of-date and unnecessary. Past Grand

Presidents over the past decade have not appointed Grand Organists and there is no rationale why the current and future Grand President shall appoint a Grand Organist. With regard to the Legal Advisor, we note the presence of redundancy in the By-Laws and that a more complete discussion of our Legal Advisor role is already covered in Article II, Section 8.

Proposal #7, Organization, Suspension, and Dissolution of Councils
Article VII

Existing Language:

The Article remains the same with the addition of the word Membership in its title, a new Section 1 and all other Sections renumbered.

Rewrite: (Add the following as the new Section 1)

Section 1 MEMBERSHIP: *Organization membership shall be divided into the following categories:*

- (a) An Associate Member Applicant is age forty-five (45) or above at the time he commences YMI membership. Said member is entitled to Educational Foundation Benefits but not entitled to the Grand Council Death Benefit.*
- (b) Honorary Members are limited to Catholic priests, seminarians and members of religious communities (i.e. deacons, brothers, etc.) Said member shall be exempt from all Grand Council dues and assessment and is not entitled to Grand Council Death Benefit of Educational Foundation Benefits.*
- (c) Junior YMI Members are limited to young men between the ages of 13-23, who are either full-time students or active in military service, as verified by the respective Councils. Such members shall be exempt from all Grand Council dues and assessments, but are similarly not entitled to the Grand Council Death Benefit nor the Educational Foundation Benefits. At age 24, said member will convert to Benefit Membership status and be eligible for the Grand Council Death Benefit and Educational Foundation Benefits.*

Rationale :

The YMI Grand Council By-Laws make several references to terms such as "Benefit Members" and "Associate Members" (see Articles V, VI and VII). However, the By-Laws do not define such terms, so it is not clear what are the distinguishing elements of these two categories of membership. Moreover no definition is provided for Honorary Members, which is another category of membership. We should correct these omissions.

Although not specifically covered by the By-Laws, membership literature indicates that anyone under 45 is considered a Benefit Member. Additionally, the literature says you must be age 17 to join (although there is no reference to this age in the By-Laws). Since the assessment of Benefit Members is more costly than for Associate Members, we end up charging younger men higher dues to be part of the YMI. As students and those in the military are often earning low-income levels, our current practice provides a financial disincentive for young people to follow in the footsteps of their fathers, grandfathers and uncles in joining the YMI. Moreover, most students see little value in the Death Benefit program that distinguishes membership. We should set forth a Junior YMI category of membership to encourage young people to join the YMI and not suffer a financial hardship. With direct exposure to the YMI at an earlier age, we might enhance membership growth and deal with the looming concern on whether the YMI's next generation will have adequate numbers to carry on to reach our bicentennial celebration .

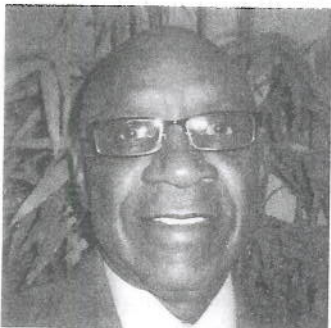

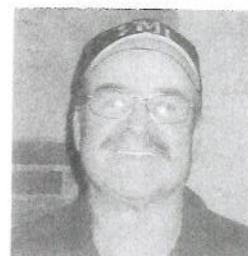

Education Foundation's Matching Funds – A Grand Success

Twenty-three Councils participated in this year's Matching Funds Program, an all time record.
