

Article VII: Membership, Organization, Suspension, and Dissolution of Councils

Current Language:

Section 2 ORGANIZATION AND PROCEDURE: Upon the written application of not less than fifteen (15) eligible applicants to form a Council under the jurisdiction of Grand Council, the Grand President shall require the Grand Secretary, or other organizing officer, to inquire into the character and qualifications of the applicants and to proceed as follows:

(a) No Council shall be organized unless and until the organizing officer is satisfied with the number and qualifications of the applicants, and all application forms have been completed and signed. No less than fifteen (15) applicants must be eligible as Benefit Members, Associate Members, or a combination of the two.

Section 5 MINIMUM NUMBER OF BENEFIT MEMBERS: if the Benefit members in any Council should fall below fifteen (15) in number, the Council shall be permitted to continue in existence and accept additional Associate and Benefit members. The Council will also be given assistance by Grand Council in the recruitment of additional members. However, it is the duty of the Council to notify Grand Council and ask for this assistance.

Section 6 SURRENDER OF CHARTER; No Council shall voluntarily surrender its Charter if *fifteen* (15) members in good standing object to its surrender, nor shall any of its funds be divided among its members or disbursed in any other way, but, upon dissolution, all funds, books, and property shall immediately be delivered to the Board of Grand Directors.

Section 8 SUSPENSION AND DISSOLUTION OF COUNCILS; Any Council failing to maintain a minimum membership of fifteen (15) members, to hold meetings for four (4) consecutive months, or failing to remit the Per Capita Tax for six (6) months after date of levy, or failing to remit the Death Benefit or Educational Assessments for sixty (60) days after date of levy, or failing to submit any required report, may be suspended or declared in a State of Reorganization by the Board, upon failure, after proper notice of at least twenty (20) days is given to show cause why such action should not be taken. Upon suspension, the Council's Charter and all funds and property shall be forfeited to the Board of Grand Directors. The suspended Council may appeal to Grand Council, but pending the outcome of the appeal the action of the Board shall stand. Councils suspended or in a State of Reorganization may be dissolved only upon the recommendation of the Grand President and the approval of Grand Council.

Proposed Revised Language:

Section 2 ORGANIZATION AND PROCEDURE: Upon the written application of not less than six (6) eligible applicants to form a Council under the jurisdiction of Grand Council, the Grand President shall require the Grand Secretary, or other organizing officer, to inquire into the character and qualifications of the applicants and to proceed as follows:

(a) No Council shall be organized unless and until the organizing officer is satisfied with the number and qualifications of the applicants, and all application forms have been completed and signed. No less than six (6) applicants must be eligible as Benefit Members, Associate Members, or a combination of the two.

The Council will also be given assistance by Grand Council in the recruitment of additional members. However, it is the duty of the Council to notify Grand Council and ask for this assistance.

Upon suspension, the Council's Charter and all funds and property shall be forfeited to the Board of Grand Directors. The suspended Council may appeal to Grand Council, but pending the outcome of the appeal the action of the Board shall stand. Councils suspended or in a State of Reorganization may be dissolved only upon the recommendation of the Grand President and the approval of Grand Council.

Rationale:

We are well aware of the grand story of the YMI's birth on March 4, 1883, when six (6) young men (i.e., McDade, Smith, Sheehan, Ryan, Gagan & Maxwell) gathered under a single lamppost in front of St. Joseph Parish Hall to form a society for the moral, social and intellectual betterment of Catholic laymen. Ironically, if these same six men came before the YMI today to seek authorization for a new Council, we would have to deny them per the above by-laws,

It is a harsh reality that the number of Councils in the YMI has been shrinking steadily, as has been our overall membership. In the past decade (if not longer), we have seen only one new Council emerge. As such, we must consider ways to make it easier for new YMI Councils to form and new areas of membership to grow. If we don't, we will continue to shrink. The current 15 applicant basis for forming a new Council appears to an arbitrary number and likely originated during a time when new Councils were forming regularly. Changing to the six applicants would go back to our roots and honor our founding fathers.
