He had actively tried to recruit me for many years to join, but I simply did not have the time as I had worked full-time managing a department of about 60-80 people and actively coached sports during my leisure time (i.e., basketball, baseball, and softball). As my children grew up and my coaching career ended, I finally relented and joined YMI #613. Within a short time, I became a YMI #613 officer and delegate. In 2008, I was elected as the YMI #613 President and served in that post for twelve consecutive years thereafter. Besides leading YMI #613, I have concurrently served proudly on the YMI Grand Council, being elected as Grand Marshall (2007), Grand Secretary (2008-2017), Grand 2nd Vice President (2018) and Grand 1st Vice President (2019). Hence, my resume includes much leadership experience in and outside the YMI!

It is fitting that my YMI Council's patron saint is St. John Bosco, as I grew up attending a Salesian school in San Francisco (i.e., Saints Peter & Paul School) and playing sports at the Salesian Boys & Girls Club. As such, St. John Bosco has been a role model for me in my life having heard many terrific stories of how this 19th century priest advocated for young men in his time and help them reach their potential as good, productive Catholics. Although the Church struggled in those days from apathy, distrust, and loss of faith (much like today), St. John Bosco successfully renewed interest in being Catholic by focusing his mission to the betterment and education of young people and by developing a revolutionary teaching method of his era focused on three basic pillars: Reason, Religion, and Loving Kindness.

For this edition of the Lamp Post, I will focus on the "Reason" pillar, while deferring discussion of the other pillars to future Lamp Post editions. The pillar of "Reason" is an important one, as it provides the explanation or justification for being a member. I would like congratulate our Grand President Mike Amato, all the new Officers and Board of Directors elected and thank them accepting the position. These times offer new challenges. Committee in past years (Brothers Cresci, Dimech, Andreatta and Kavanagh to

name a few). We also have some core files of YMI historical data spanning 137 years of operations, which was developed way back in 1948 and updated about 20 years ago when Br. Fourie was the Grand President. Sadly, my perception in talking with YMI Brothers is that many do not know much about the YMI history and that may be because access to our history in extremely limited. Hence, under the Reason pillar, there are two specific areas that we can work to improve:

1. The YMI Grand Council's Organization Committee should take the lead and build on the YMI History to bring it up to date and to make it available to all the YMI via the website. This way we can fully understand our roots.

2. Each YMI Council should review their own outreach methods to recruit new members and should designate a YMI Brother (or a Group of Brothers) to be the Membership Recruiting Coordinator. Recruiting needs to be an active process each month and not just a once of year activity.

Before concluding my remarks, I want to emphasize that St John Bosco was also a person that was not afraid to make changes to the status quo. Although he had some opponents high in the Catholic church that did not like his new approaches, St. John Bosco was not deterred and kept going forward to build a successful order that extends throughout the world today. Similarly, the YMI has made some good important changes over the past few years, which I have listed several in my Grand President's Program. Currently, we are dealing with a serious Covid pandemic, which has caused some Councils to resultingly suspend operations in response to public health restrictions. As a cure for Covid may be awhile away, we will need to look at making new changes in how Councils meet and hold events. I have noticed that a few Councils are meeting over Zoom or using teleconferencing, while other Councils are meeting outdoors keeping social distance apart and wearing masks. Moreover, the YMI Grand Directors will be using Zoom at its next meeting in September for the very first time. I applaud all these innovative steps to respond to the pandemic and I encourage other Councils to consider changes they can make, so that we can meet safely in the short-run and allow the YMI to succeed over the longer term.

ARCHIVE FINDINGS

As reported during the July Board of Grand Directors Meeting, a group of four YMI Officers visited and cleaned out the remains of the YMI Archives, located in a closet at All Souls Catholic School in South San Francisco.


Looking through much of the YMI history and keeping in mind one of Grand President Michael Amato's goals for this year, a record of past Institute Journals and Advance Proceedings was recorded.

Advance Proceedings (programs for each year's Grand Council Session) were found for every year going back to 1952. In addition, Advance Proceedings from 1932, 1937, 1939, 1940, 1942, 1944, 1945 and 1946 were also located. This totals 76 years of recorded history of the YMI.

As for the Institute Journals (the Lamp Post) copies dating back to 1960 were found as well as very old volumes going back as far as the late 1800s. However, there is one significant gap – that being issues dating from 2002-2015.

If any Brother or Council has copies of any missing documents to fill in the void – the Grand Council Office would be happy to accept them in order to complete the YMI story from the past 135 years.
