Approval of the Minutes from the Board of Grand Directors September 16, 2023

Meeting — Chairman of the Board, Brother Tommy Figueira #573, Grand Director, asked for a motion to accept the minutes from the September 16, 2023 Board of Grand Directors meeting. Brother Michael Amato #613, PGP, GD asked that his additional paragraph be added to the pre printed minutes. Brother Michael Amato #613, PGP, GD then made a motion to accept the minutes from the September 16, 2023 as amended. The motion was seconded by Brother Nick Franceschine #54, PGP, GD. There was no other discussion. The Board unanimously accepted the minutes as corrected.

Communications - Brother Michael Dimech #613, Past Grand President, Grand Secretary reported that he had received Council newsletters and had forwarded them to the Webmaster for publication.

Reports of the Grand Treasurer – Brother Jack Albrecht #32, GT presented the Grand Treasurer's two-page financial report that had been e-mailed to all Officers the week previous. A motion was made by Brother Paul Larson #32, GD to accept the Treasurer's Report as presented. The motion was seconded by Brother Nick Franceschine #54, PGP, GD. The report was approved unanimously.

Brother Jack Albrecht #32, GT made an announcement that after over 20 years of service as Grand Treasurer he would like to retire effective today, November 18, 2023. Brother Steve Cresci #32, GP thanked Brother Jack for his many years of service and accepted his retirement. As Grand President and in following the By-Laws of Grand Council, Brother Steve Cresci #32 nominated Brother Bob Bartoli #32, PGP and Assistant Business Manager for the position of Grand Treasurer for the remainder of the current YMI year. Brother Bartoli accepted the nomination. Brother Michael Amato #613, PGP, GD made a motion to accept the Grand President's nomination of Brother Bartoli and it was seconded by Brother Nick Franceschine #54, PGP, GD. The nomination was approved unanimously.

There was no report from this committee at this time.

<u>Finance:</u> Brothers Michael Amato #613, PGP as Chairman, Alexander Schmitt #8, and Paul Larson #32

This committee reviews the monthly bills of Grand Council and two members sign off on each bill. This is usually done around the 15th of the month in conjunction with the Business Manager and the Grand Treasurer. All the bills have been paid at this time.

<u>Long Range Planning:</u> Brothers Alexander Schmitt #8 as Chairman, Mario Balistreri #613, Nick Franceschine #54, PGP, and Michael Amato #613, PGP

Brother Alex Schmitt said that he needed to set up a meeting with Brother Tommy Figueira, Brother Mario Balistreri, Brother Nick Franceschine and Brother Michael Amato to begin to review the current document, and plan for the next report. He mentioned that he had an email from Brother Rob Bartoli #32 to consider in formulating the next plan.

<u>Council Activities</u>: Brothers Domenic Carinalli #54 as Chairman, Paul Larson #32, and Richard Murphy #32

There was no report from this committee at this time.

<u>Insurance:</u> Brother Michael Amato #613, PGP will be available to represent the Board as the insurance issues (should they arise) are handled directly through the Grand Council Office.

<u>Supplies:</u> Brothers Mario Balistreri #613 as Chairman, Richard Murphy #32 and the staff of the Grand Council Office.

There was no report from this committee at this time. However, Brother Phil Oberst #32, PGP spoke to the information he had collected with regard to purchasing 25 year and 50 year pins for the Order. He reviewed the cost structure which was considerably less than past pin orders (\$16.61 for a 50 year pin and \$9.55 for a 25 year pin). Brother Michael Amato #613 made a motion to purchase the pins and it was seconded by Brother Alex Schmitt #8.

<u>Grand Council Planning Committee</u>: Joining Brothers Tom Fourie #32, PGP, Bob Bartoli #32, PGP Michael Dimech #613, PGP & GS, and Michael Amato #613, PGP, GD, will be Steve Cresci #32 as Grand President to complete the committee in August.

On behalf of the Committee, Brother Tom Fourie #32, PGP reported that at the request of several members of the committee a different dinner setting for Tuesday night at the Convention might be planned. The committee was looking at a Basque Dinner in Gardnerville, Nevada (over the hill from South Lake Tahoe). For transportation, a bus might need to be reserved to make driving easier on those who wish to attend. Working with the folks at the hotel to pursue this option.

He volunteered to look into the bus companies for bids. Brother Phil Oberst would also look into a possible limo company for bids. All Souls Church could again be the meeting point.

Reports of Grand Directors to Grand Council Committees: in accordance with the Grand Council By-Laws a member of the Grand Council Board of Directors is to be assigned to each of the Grand Council Committees that are delineated in the Grand President's Program for 2023-2024. In the program, each committee chairman as chosen by the Grand President is listed along with the goals and objectives of each committee.

The following are the Board Appointments and current reports for 2023-2024:

Audit Committee – Board Appointments: Brother Michael Amato #613, PGP and Brother Domenic Carinalli #54. Committee Chairman is Brother Bob Bartoli #32, PGP.

On October 24, 2023 both Council #44 and #80 were audited via Zoom and completed without any issues. Council by-laws for Council #44 and #80 are current. However tied to this Committee report is how the Laws and Revision report fits in as presented below,

The Laws and Revisions Committee has reviewed the revised by-laws of the following Councils: (provided by Chairman Rob Bartoli #32)

Council #8 (American)

Council #40 (Santa Rosa)

Council #59 (Sadoc)

Council #92 (Tracy)

Council #94 (St. Columba)

Council #497 (St. Augustine)

The six Councils have made revisions to their by-laws that eliminate references to Associate members.

In review of these changes, I noticed that, with the exception of Council #59, there was not a change to the length of time a member has to be in good standing for. The requirement is not 5 years for a new member to vest the death benefit. Council #8 (Article 10, Section 1), Council #40 (Article #3, Section 1), Council #92 (Article 9, Section 1) and Council #497 (Article 10, Section 1) all state that "A Benefit Member shall be entitled to the Grand Council Death Benefit, providing he has been a Benefit Member for at least six (6) months and is in good standing with the Council as required for Grand Council Benefits. I also noticed this for Council #54, which I had previously recommended for approval.

The by-laws for these Councils, with the exception of Council #59, will need to be revised to change the time period from 6 months to five years. Currently I would only recommend the approval of Council #59 by-laws.

The Grand Council Office needs a copy of Council approved by-laws.

The Audit Committee and the Laws and Revisions Committee are working hand in hand this year given their respective chairmen.

Budget Committee – Board Appointments: Brother Alex Schmitt #8 and Brother Tommy Figueira #573. Committee Chairman is Brother Bob Bartoli #32, PGP, GT.

See Review Information regarding the budget as to increasing the Per Capita Tax. Brother Alex Schmitt made mention to increase the per capita tax for next year.

Reserve Committee – Board Appointments: Brother Nick Franceschine #54, PGP and Brother Richard Murphy #32. Committee Chairman is Brother Bob Bartoli #32, PGP, GT.

There was no report from this committee at this time.

Institute Journal Committee – Board Appointments: Brother Paul Larson #32 and Brother Mario Balistreri #613. Committee Chairman is Brother Tom Fourie #32, PGP.

The next issue of the Institute Journal is scheduled to be published in December. All content articles should be submitted to the editor before this time period, especially an article from the Budget Committee (see above). Other articles might be the Man/Council of the Year, Need for Resolutions, Essay Contest, Seminarian and Matching Funds letter, Bowling and Golf.

Laws & Revisions Committee – Board Appointments: Brother Nick Franceschine #54, PGP and Brother Michael Amato #613, PGP. Committee

Chairman is Brother Rob Bartoli #32. The report for this committee is contained in the Budget Committee section of these minutes.

There is no other report from the committee at this time.

Man and Council of the Year Committee – Board Appointments: Brother Paul Larson #32 and Brother Richard Murphy #32. Committee Chairman is Brother Bob Bartoli #32, PGP.

Applications for both Man of the Year and Council of the Year will be on the YMI website and in the next edition of the Lamppost. The committee will also be mailing a copy to each Council of both applications.

Membership Committee – Board Appointments: Brother Alex Schmitt #8 and Brother Michael Amato #613, PGP. Committee Chairman is Brother Robert Laxner #59.

The Grand President reported the Committee is scheduled to meet on December 9, 2023.

Pro Deo Committee – Board Appointments: Brother Richard Murphy #32 and Brother Paul Larson #32. Committee Chairman is Brother Bill Walls #80, GSVP

The Chairman reported that the Church and Mass are ready to go for March 2024. He is working out the details of the dinner with Brother Espinola #94.

Pro Patria – Board Appointments: Brother Mario Balistreri #613 and Brother Nick Franceschine #54, PGP. Committee Chairman is Brother Bill Avery #80. GFVP.

The committee chairman reported on the mailing of the raffle tickets and the essay entry forms via bulk mail.

Organization Committee – Board Appointments: Brother Tommy Figueira #573 and Brother Mario Balistreri #613. Committee Chairman is Brother Michael Dimech #613, GS.

There was no report from this committee at this time.

Workshop Committee – Board Appointment: Brother Michael Amato #613, PGP. Committee Chairmen are the Staff of the Grand Council Office.

This committee will announce its plans for next year in May 2024.

Report of Sports Committees

Chairmen of the Sports Group of Committees: the following announcements were made. (same as from the previous Board Meeting)

Bowling – Brother Michael Sanzeri #59 – the Bowling Tournament will be held on April 21, 2024 at the Pacific Avenue Bowling Alley in Stockton beginning at 1:00 p.m. A flyer will be sent out and also printed in the Institute Journal.
