### Minutes from the June 20, 2023 Meeting

**Reading of the Minutes:** The distributed minutes of the May 5<sup>th</sup> SEF meeting were approved unanimously after a motion was made by Br. Sanzeri #59 and seconded by Br. Reza #900.

**Treasurer's report:** Br. Fourie #32 provided an overview of the Treasurer's Report presented in the Advance Proceeding Handbook (pp.112-118) covering the financial activity for the period ending March 31, 2023. No questions were asked. Motion to approve the report was made by Br. Evans #80 and seconded by Br. Avery #80 and the motion was approved unanimously.

Reading of the bills: Br. Fourie #32 reported no bills were received during the period.

**Communications:** Br. Fourie, #32 reported receiving information via Br. Rohe #612 that a YMI sponsored seminarian (Jack Wright) was ordained on June 3<sup>rd</sup> and presided over his 1<sup>st</sup> Mass before YMI #612 Brothers in Indiana. This news received applause from the delagates.

Committee reports: None.

#### **Unfinished Business:**

- 2023-2024 Board Officers: With the 3-year terms of 3 Board Members (Bartoli, Dimech, and Gobbo) ending, Br. M. Amato reported that Br. Bartoli #32 sought a new 3-year term and that Br. Dennis Cresci, #32 and Br. Paul Walsh requested to be considered for open Board positions. Motion made Br. Fonseca #99 and seconded by Br. S. Cresci to appoint Brs. Bartoli, D. Cresci, and Walsh to fill the Board term ending in 2026. Motion passed unanimously.
- Seminarian Applications: Br. Fourie #32 summarized the SEF 2023 activity namely that a record-high 59 seminarian applications seeking YMI Scholarships were approved. The applications involved 6 YMI Councils and came from 9 different locations/sources with the most coming from the Fresno Diocese (19 applications), followed by the San Francisco Diocese (8 applications), and then the Hawaii, Oakland, and San Jose Dioceses (each with 7 applications). After applying the approved YMI scholarship criteria, the 59 applications totaled \$35,300. After his summary, Br. Fourie #32 presented checks to the 6 YMI Councils that sponsored seminarians for future distribution to those seminarians. President Andreatta #32 thanked all the YMI Councils that participated in the effort.

• Br. Guaraldi #32 inquired about the status of other seminarians supported by the SEF and encouraged the SEF Board to follow-up to determine if they were able to become priests.
